from the PIO o/o **MC**, **Zone B**, **Ludhiana**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **8.9.2022**. Notice was issued to the parties for first hearing in the Commission on **22.11.2022**.

2. Both parties are present. After deliberation at this hearing, during which the complainant Sh. Gurcharan Singh, Senior Citizen age of 83 states that his essential purpose is to obtain the information sought in this RTI application. The Commission deems it fit to remand back this Complaint Case to the First Appellant Authority-cum-Joint Commissioner, who is hereby directed to hear both parties and issue an appropriate Order as per the provisions of the RTI Act, 2005. In the event that the complainant Sh. Gurcharan Singh is not satisfied with the decision of the FAA, he can file Second Appeal to the Commission where after the Commission will hear this as an Appeal Case.

3. This Complaint Case is accordingly **Disposed of**.
