**ORDER:**

1. The RTI application is dated 29.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 30.09.2022 and the second appeal was filed in the Commission on 30.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 08.02.2023. Accordingly, the case has been heard today. Shri Ram Rattan, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.

3. Shri Raj Kumar Bansal, Administrative Officer/PIO, PUDA, Mohali comes present to attend the hearing through cisco webex and states that the RTI application was transferred to PIO O/o GMADA, Mohali.

4. Shri Gurwinder Singh, AEO/PIO, GMADA, Mohali comes present to attend the hearing through cisco webex. He states that the appellant has sought reasons for delay in preparation of duplicate file of Booth No.307, Janta Market, Phase-3B1, Mohali and that reply to the appellant has been given vide letter dated 03.02.2023 stating that the matter is still under consideration. He further states that the grievance of the appellant will be redressed.

4. The Bench observes that the appellant has sought reasons for the delay in redressal of his grievance and the Bench is convinced that the requisite information stands supplied to the appellant by the PIO.
5. The Bench directs the PIO to send a copy of the same again to the appellant with a copy to the Commission by e.mail.
6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copy of the order be sent to the parties.
