He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

5. Respondent PIO is directed to bring reply in connection action taken in connection with point no. 3 and 9 of the RTI application as per previous order passed by the Commission on 11.01.2023 in the instant appeal case. A copy of previous order dated 11.01.2023 be sent o him along with this order through registered post for his ready reference.
