**ORDER**

1. The RTI application dated 23.8.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 3.10.2022 and second appeal was filed in the Commission on 1.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 31.01.2023 at 11.00 a.m. i.e. today.
3. In today's hearing both the parties are present.
4. Respondent, Ms. Martha Gill states that reply as per RTI application was sent to the appellant on 04.10.2022.
5. The appellant states that he is not satisfied with the supplied reply as only numbers are given but copy of complaints are still pending as per RTI application.
6. After having detailed discussion with both the parties and examining the case file, respondent intimates the Commission that demanded information is voluminous in nature and requests the appellant to specify the particular required information.
7. On this, appellant states that information from 01.01.2019 to 31.12.2020 (of 2 years) is required.
8. Accordingly respondent PIO is directed to supply the information for the time period from 01.01.2019 to 31.12.2020 within 01 month (as time requested by the respondent during the hearing) along with directions to represent this case on the next date of hearing positively to clear the facts of this case.
9. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
10. Matter is fixed for hearing on **07.03.2023 at 11:00 A.M. at Punjab State Information Commission**. Copy of the order be sent to the parties.
