ORDER

- 1. This order may be read with reference to the order dated 30.05.2023 passed by this Bench on the previous hearing.
- 2. The case has been heard today. As per the PIO, the appellant did not visit their office for inspection as per order of the Commission. The PIO further states that there is no documentary evidence available on record with regard to the authority on whose directions change of ownership and change of mobile number has taken place in the portal of GMADA.
- 3. The PIO is directed to comply with the earlier order of the Commission and allow the appellant access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to him duly attested by the PIO relating to the RTI application.
- 4. The appellant is advised to contact <u>Smt.Bhupinder Kaur, PIO O/o GMADA Mohali Mobile No. 9888322295</u> prior to visiting for inspection of records. The PIO is directed to ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO.
- 5. Having gone through the record, the Bench observes that the appellant has also filed a similar appeal case No.1744 of 2023 for seeking exactly the same information whereas in a certificate along with the appeal filed in the Commission, the appellant has undertaken that the matter under appeal or complaint has not been previously filed or is pending or decided by any of the State Information Commissioners. Hence both the cases are being clubbed together for decision.
- 6. With the aforesaid directions, the case is **disposed off and closed.** Copies of the order be sent to the concerned parties.
