ORDER

This order may be read with reference to the previous order dated 14.02.2023. The case was fixed for hearing today.

The appellant has sought the following information:

“Attested copies of Service Record including salary slips w.e.f. 01.04.2021 to till date of Sukhpal Singh s/o Sh Balwinder Singh, Math Lecturer at Govt. Sr. Sec. School, Gatwali, Bathinda.”

2. The appellant is absent today without any intimation to the Commission despite the fact that a copy of order dated 14.02.2023 was sent to her through registered post. The appellant has not contacted the Commission to pursue her case.

3. The 3rd party Sh. Sukpal Singh is present today. He states that his information relating to salary and service book is personal information. He requests the Commission that his information may kindly not be shared with the appellant as he has marital dispute with her and the case is pending in the Court. The respondent PIO submits that salary slip and service book contain personal information of Sh. Sukhpal Singh, Math Lecturer and thus cannot be provided to the appellant.

4. After hearing the respondent parties, going through the case file, the Commission does not fully agree with the contention of the respondents.

5. Keeping in view of the above and after detailed deliberations with the respondent parties, the PIO is hereby directed to provide the information to the appellant regarding gross salary of Sh. Sukhpal Singh, Math Lecturer in the light of Section 4 of the RTI Act, 2005 within a week from issue of this order.

6. That no more cause of action is required in this case. Hence this case is disposed of and closed. However, since the appellant is absent today, she is at liberty to approach the Commission within one week if she does not receive the information as directed in foregoing para 5.
