ORDER:

1. The RTI application is dated 20.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.10.2022 and the second appeal was filed in the Commission on 06.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 08.02.2023. Accordingly, the case has been heard today. Shri Vinod Kumar Singh, appellant comes present to attend the hearing in person before the Bench and states that he was called to GMADA office on 02.12.2022 but he was not entertained and no information has been supplied to him.

3. Shri Gurwinder Singh, PIO, PUDA, Mohali comes present to attend the hearing through cisco webex. He states that RTI application has been transferred by PUDA to GMADA on 12.01.2023 and reply has been given to the appellant to the effect that the information asked for regarding parking/stack parking etc. is available on the website of PUDA. The appellant, however, stated that the norms of such parking on the website are vague and not clear.

4. Post deliberations, the Bench directs the PIO O/o GMADA, Mohali to call the appellant to office of GMADA and allow him access to the relevant record. The PIO assures that he will coordinate with the District Town Planner of GMADA so that appellant is shown all the relevant information on the website and requisite information will be provided to the appellant.

5. In view of the assurance as given above by the PIO, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
