**ORDER**

1. The RTI application is dated 24.05.2021 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 20.09.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 16.11.2022. The case has been heard today. Shri Randhir Singh, complainant has not come present to attend the hearing in person before the Bench or through cisco webex.

3. Shri Sardul Singh, ASI, RTI Cell, O/o SSP Ropar comes present in person before the Bench and states that RTI application of the complainant was received on 25.05.2022 and the same was transferred u/s 6(3) of RTI Act to the PIO O/o SSP Mohali. He also refers to letter dated 31.10.2022 in this regard which is addressed to the Hon'ble Commission.

4. Smt. Rajwinder Kaur, HC RTI Cell, O/o SSP Mohali comes present in person before the Bench and produces before the Bench letter dated 31.10.2022 along with letter dated 04.06.2022 informing the complainant that the record relating to the period 2006 to 2008 has been destroyed in the

presence of a committee constituted for the purpose on 27.10.2014 and that the record relating to the information sought for the year 1997 has also been destroyed on 27.10.2014 and thus, the information asked for cannot be supplied.

5. The complainant has neither come present in person before the Bench nor through cisco webex nor he has sent any intimation in this regard. The Bench presumes that the complainant has received reply to his satisfaction.

6. In view of the above, no further action is called for. **The instant complaint case is disposed off and closed.** Copy of the order be sent to the parties.
