**ORDER**

1. The RTI application is dated 27.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.10.2022 and the second appeal was filed in the Commission on 09.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.02.2023. Accordingly, the case has been heard today. Shri Ashok Kumar Watts, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. The PIO O/o Municipal Corporation, Abohar has also not come present to attend the hearing on behalf of the PIO in person before the Bench or through cisco webex. However, a letter 25.1.2023 received in the Commission by post is available vide which point-wise information has been supplied to the appellant. Another letter dated 13.02.2023 received by post is also available vide which the Coordinator, RTI, M.C. Abohar has informed that the appellant has received this information and has requested for closing this appeal case.
4. On the perusal of the case file, the Bench observes that a letter dated 13.02.2023 from the appellant is also available vide which the appellant has confirmed receipt of information and has also given his consent to close the appeal case.
6. In view of the above, no further cause of action is left in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
