ORDER:

1. The RTI application is dated 20.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.09.2022 and the second appeal was filed in the Commission on 09.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.02.2023. Accordingly, the case has been heard today. Shri Gurmej Lal, comes present to attend the hearing on behalf of the appellant through cisco webex. He states that no information has been provided to the appellant.
3. Shri Rajiv Kumar, Senior Assistant, Town Planning Wing, Local Govt. Punjab comes present in person before the Bench. He states that point-wise reply has been given to the appellant vide letter dated 16.02.2023 explaining the position on each point. He further states that the complaint on which action taken report has been sought, has been sent to the Commissioner, Municipal Corporation, Ludhiana vide e.mail dated 09.09.2022, however, no report has been received from the Department yet.
