

ORDER:

- The RTI application is dated 12.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 18.05.2022 and the second appeal was filed in the Commission on 12.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 13.02.2023. Accordingly, the case has been heard today. Shri Suresh Kumar, appellant comes present to attend the hearing through cisco webex. He states that no information has been received by him so far.
- 3. Shri Sukhwinder Singh, Assistant Engineer and Shri Simarjit Singh, Junior Engineer come present in person before the Bench to attend the hearing on behalf of the PIO O/o Municipal Corporation, Amritsar. Shri Sukhwinder Singh states that the information sought by the appellant relating to civil works, has yet not been supplied and seeks additional time to supply the information to the appellant.
- 4. The appellant is apprised of the version of the respondent and that the PIO is being directed to ensure to supply information before the next hearing.
- 5. The request of the respondent is acceded to. The PIO is directed to ensure to supply information to the appellant before the next hearing.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 13.04.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
