ORDER

1. The RTI application is dated 11.07.2022 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 21.09.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.11.2022. The case has been heard today. Mrs. Surinder Kaur, complainant comes present in person before the Bench.
3. Shri Gurjinder Singh, Sr. XEN, PSPCL, Bhogpur, comes present in person before the Bench to attend the hearing on behalf of the PIO O/o Dy. Chief Engineer, Distribution Division, PSPCL, Hoshiarpur and produces before the Bench letter dated 14.11.2022 whereby he has been authorized to attend the hearing. He states that the appellant is getting family pension and the information sought by her in her complaint case relates to PSPCL Division, Kartarpur, District Jalandhar who has been asked to take necessary action in the matter vide their office letters dated 11.05.2022 and 27.06.2022 and the complainant has also been informed vide letter dated 17.08.2022. Thereafter, after filing of complaint by the complainant in the Commission, the Sr. XEN/Operation Division, Kartarpur vide his memo dated 11.11.2022 has sent the information to the complainant by registered post and this letter was given to the complainant by hand by this office. He also apprises the complainant that the matter regarding revision of her pension is under consideration with PSPCL Head Office, Patiala.
4. On the asking of the Bench, the complainant confirms the receipt of information. The Bench apprises her that the requisite information stands supplied to him and the action which remains to be taken in her case is an executive action and is to be taken by the PSPCL authorities.
5. In view of the above, no further cause of action is left in the matter. **The instant complaint case is disposed off and closed.** Copy of the order be sent to the parties.
