ORDER

1. The RTI application is dated 7.6.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.7.2022 and second appeal was filed in the Commission on 12.1.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for 30.5.2023 through CISCO WEBEX application.
2. In today's hearing both the parties are present.
3. The appellant states that he has sought information as per his RTI application and nothing is received till today. He further pleads that suitable directions be given so that he may get the information.
4. The respondent states that the case (CRM-M-11290/2022) is pending with the Hon'ble Punjab & Haryana Court i.e. why the information cannot be given. He adds that an email dated 29.5.2023 has already been sent to the undersigned Bench, which is received and taken on record.
5. The court asks the respondent whether the Hon'ble High Court has restricted them for supply of information. The respondent states no in this regard.
6. After hearing the respondent, the court directs the PIO concerned to supply point-wise and clear information to the appellant within 15 days as per RTI application under intimation to the Commission.
7. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
8. With the aforesaid directions, the matter is adjourned for further hearing on **06.09.2023 at 11:00 A.M. through CISCO Webex application.** Copy of the order be sent to the parties.
