**ORDER**

1. The RTI application is dated 17.08.2022 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 21.09.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.11.2022. The case has been heard today. Shri Gurbachan Singh, complainant comes present in person before the Bench.
3. Shri Gurjinder Singh, Sr. XEN, PSPCL, Bhogpur, comes present in person before the Bench to attend the hearing on behalf of the PIO O/o Dy. Chief Engineer, Distribution Division, PSPCL, Hoshiarpur and produces before the Bench letter dated 14.11.2022 whereby he has been authorized to attend the hearing. The respondent states that as the complainant had retired from PSPCL Moga Division, the information sought by him relates to PSPCL Moga and as such, PSPCL Division, Moga has been requested vide letter dated 06.06.2022 and 27.06.2022 to take necessary action with regard to revision of pension of the complainant as per Finance Circular dated 20.12.2019 . The representative of PIO also states that after filing of RTI by the complainant, he has also been apprised of the action taken by PSPCL Moga vide letter dated 11.11.2022 which has been given to the complainant by hand. He also apprises the complainant that the matter regarding revision of his pension is under consideration with PSPCL Head Office, Patiala.
4. On the asking of the Bench, the complainant confirms the receipt of information. The Bench apprises him that the requisite information stands supplied to him and the action which remains to be taken in his case is an executive action and is to be taken by the PSPCL authorities.
5. In view of the above, no further cause of action is left in the matter. **The instant complaint case is disposed off and closed.** Copy of the order be sent to the parties.
