2. The complainant is absent without intimation. The respondent PIO-cum-Superintendent, Tehbazari Branch, Zone B, MC, Ludhiana, Sh. Rajeev Bhardwaj, has submitted copy of a pointwise reply that was first sent to the complainant along with the available information vide Letter No. 51/TBS/B Dated 13.7.2022. Following the institution of this Complaint to the Commission, the respondent PIO once again sent a detailed pointwise reply vide Letter No. 56 Dated 8.12.2022, along with duly attested copies of the information.

3. This is however, a Complaint Case and the only question before the Commission is to determine that there was any malafide intent on the part of the respondent PIO to delay/deny the information. This Commission is of the view that there was no malafide intent on the part of the PIO to delay/deny the information requested. This Complaint is accordingly **Disposed of**.
