Order

1. The RTI application dated 16.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.09.2022 and second appeal was filed in the Commission on 14.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 26.04.2023 at 11.00 a.m. i.e. today.
2. In today's hearing, Sh. Gaurav Patial, appellant states that incomplete information has been supplied to him. He further mentions that the department is sending not legible pages to him, which has black spots on it. He adds that he has sent a letter dated 20.02.2023 in this regard, which is received vide diary no. 5520 dated 28.02.2023 and taken on record.
3. Respondent, Sh. Gurmeet states that the information as per official record has been supplied to the appellant and requests the appellant to inspect the official record for deficit information, so that identified pages could be supplied.
4. After discussing with both the parties in detail, appellant is advised to visit the respondent's on 02.05.2023 at 12:00 Noon to inspect the official record and obtain the information as available in the official record; and the respondent PIO is directed to supply the pending information to the appellant after inspection within seven days after the inspection under intimation to the Commission, in accordance with the relevant provisions of the RTI Act, 2005.
5. If the Appellant, Shri Gaurav Patial will not visit for inspection on the said date and time then it would be presumed that he does not require the information anymore and the case will be decided on merits.
6. Matter is adjourned for further hearing on **22.06.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
