ORDER

- 4. On the asking of the Bench, the appellant, on perusing the copy provided, states that the information provided is irrelevant and not as was asked for vide his RTI application and the documents provided relate to another case.
- 5. Post deliberations, the Bench directs the PIO O/o SDM, Abohar to call the appellant to his office on an working day and allow him access to the relevant official records and provide point-wise information to the appellant as is identified by him after inspection of records before the next hearing. The PIO O/o SDM, Abohar is also directed to come present in person before the Bench along with the entire relevant record.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 20.04.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
