ORDER

- 1. The RTI application is dated 23.09.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.10.2022 and the second appeal was filed in the Commission on 16.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 20.02.2023. Accordingly, the case has been heard today. Shri Rajan Chaudhary, appellant comes present to attend the hearing in person before the Bench.
- 3. Shri Paramjit Singh, Patwari, Mandi Abohar also comes present in person before the Bench to attend the hearing on behalf of the PIO and states that the appellant has been supplied information.
- 4. On the asking of the Bench, the appellant states that the information provided is incomplete as information only on point No.7 of his RTI application has been given. The respondent is, however, unable to explain the reasons for not addressing other points of RTI application and providing only partial information.
- 5. Post deliberations, the Bench directs the Tehsildar, Abohar to provide point-wise information to the appellant before the next hearing. The Tehsildar, Abohar is also directed to come present in person before the Bench along with the entire relevant record.
- 6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 20.04.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
