ORDER:

1. This order may be read with reference to the previous order dated 20.02.2023 passed by this Bench during the previous hearing.
2. The case has been heard today. Shri Rajesh Kumar Thakral, appellant comes present to attend the hearing in person before the Bench and states that all the points of his RTI application have been addressed by the respondent except point No.8. He further adds that this information has been supplied to him after a lapse of eleven months.
3. Shri Rakesh Kumar, Clerk O/o DDPO, Fazilka comes present in person and states that point-wise reply/information has been supplied to the appellant vide letter dated 05.04.2023 by registered post. He further clarifies that information pertaining to point No. 8 is related to the O/o Nagar Council, Fazilka and hence no inputs could be given.
4. Post deliberations and going through the RTI application of the appellant, it is observed that information which was related with the O/o DDPO, Fazilka stands provided and information pertaining to point No.8 is related to Nagar Council, Fazilka. The PIO O/o DDPO, Fazilka is directed to transfer the same to the concerned department. The appellant is also advised to file a fresh RTI application and get the remaining information from the Nagar Council, Fazilka.
5. In view of the above, no further cause of action is left in the instant appeal case. The case is disposed **off and closed**. Copies of the order be sent to the parties.
