ORDER

1. The RTI application dated 04.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.08.2022 and second appeal was filed in the Commission on 13.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 26.04.2023 at 11.00 a.m. i.e. today.
2. In today's hearing, the representative of the appellant, Sh. Phoola Singh submits his authority letter to the undersigned and further requests to direct the respondent PIO for supplying the demanded information. Authority letter in original submitted by Sh. Phoola Singh is taken on record in Appeal Case No. 6307 of 2022 and a copy of the same is taken on record in this case.
3. The respondent PIO states that the information pertains to the 3rd party and could not be supplied to the appellant.
4. After going through the case and discussing with both the parties, I am of the view that the concerned PIO is directed to supply the information i.e. salary slip of Sh. Akbar Salim to the appellant within 20 days from today as per RTI application with a copy to the Commission.
7. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
8. Matter is adjourned for further hearing on **01.06.2023 at 11:00 A.M. through CISCO WEBEX**. Copy of the order be sent to the parties.
