**ORDER**

1. The RTI application dated 10.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 31.08.2022 and second appeal was filed in the Commission on 13.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 26.04.2023 at 11.00 a.m. i.e. today.
2. In today's hearing, the appellant, Sh. Yash Pal Garg expresses his dissatisfaction in connection supplied information of point number 5 and 8 of the RTI application even after depositing the fee amounting Rs. 440/- (200+240) respectively.
3. The respondent, Sh. Inderpal Singh states that information in connection with point no. 5 and 8 relates with different projects and could not be supplied. He requests the appellant to inspect the official record on any working day in this regard.
4. After going through the case file and discussing with both the parties, I am of the view that Sh. Yash Pal Garg, appellant is directed to visit the concerned office on 08.05.2023 (Monday) at 12.00 Noon and meet the concerned PIO / officials for collecting the record after inspecting the same in connection with point no. 5 and 8 as per RTI application.
5. The PIO and other concerned officials including Sh. Inderpal Singh, Executive Assistant are directed to be there at the time of inspection on the said date and time on the Appellant's visit. The PIO is also directed to supply the requisite information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection in connection with point no. 5 and 8 of the RTI application, so that case could be concluded on the next date of hearing.
6. If the Appellant, Shri Yash Pal Garg will not visit for inspection on the said date and time then it would be presumed that he does not require the information anymore and the case will be decided on merits.
7. Matter is adjourned for further hearing on **06.06.2023 at 11:00 A.M. through CISCO WEBEX**. Copy of the order be sent to the parties.
