**ORDER:**

1. The RTI application is dated 14.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 15.11.2022 and the second appeal was filed in the Commission on 16.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today. As per respondent, the information does not relate to them and they have transferred the RTI application to the office of Chief Town Planner, Pb Chandigarh. As per copy of letter received from the PIO- O/o Chief Town Planner, Pb, Chandigarh, the information relates to the office of Director Local Govt Punjab(Town Planning Wing) and they have further transferred the RTI application to them under section 6(3) of the RTI Act on 31.03.2023.

3. The appellant is absent nor is represented. The PIO O/o Director, Local Govt. Punjab (Town Planning Wing), Sector 35-A, Chandigarh is impleaded in this case and directed to look at the RTI application and provide point-wise information to the appellant. A copy of RTI application is being sent to the office of Director Local Govt, Punjab along with the order. Both the parties are directed to appear in person on the next date of hearing.

4. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 13.06.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
