**ORDER:**

1. This order may be read with reference to the order dated 11.05.2023 passed by this Bench on the previous hearing.

2. The case has been heard today. As per respondent present from the office of Principal Secretary, Housing and Urban Development, the information relates to PUDA, the RTI application has been transferred to them under section 6(3) of the RTI Act vide letter dated 28.11.2022 and the appellant was asked to contact the office of PUDA for information. The respondent also submits reply to the show cause notice which is taken on record.

3. The respondent present from the office of PUDA states that the complaint of the appellant dated 11.11.2021 was received from Suptd. O/o Chief Vigilance Officer in their office on 03.12.2021 and the same was sent to the office of Chief Administrator, GLADA, Ludhiana for enquiry. Further the RTI application received from the office of Principal Secretary Housing and Urban Development has also been transferred to the office of Chief Administrator, GLADA, Ludhiana and since the enquiry is pending with the office of GLADA Ludhiana, reply to this effect has been sent to the appellant vide letter dated 23.06.2023. The respondent also submits a copy of reply to the Bench which is taken on record.

4. The appellant is absent nor is represented. The appellant is contacted on his mobile and he confirms the receipt of reply.

5. Since the enquiry is pending with the office of GLADA, Ludhiana and reply to this effect has been sent to the appellant, no further cause of action is left. The show cause notice issued is dropped and the case is **disposed off and closed**. Copies of the order be sent to the concerned parties.
