ORDER:

1. This order may be read with reference to the order dated 12.04.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. As per respondent, the information/reply has been provided to the appellant vide letters dated 03.10.2022, 28.10.2022 & 21.11.2022. The respondent also submits a copy of information/reply to the Bench which is taken on record.
3. The appellant is not satisfied and states that he has received reply from the PIO stating that the flour mill area comes in the red line area. Beyond that nothing has been disclosed.
4. Post deliberations, the PIO is directed to call the appellant to his office on any working day and allow him access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to him before the next hearing. The appellant be charged only for the documents provided after inspection of records.
5. The appellant is advised to contact Shri Narayan Dutt, AAE, PSPCL Shutrana - Mobile No.9646110064 prior to visiting for inspection of records. The PIO is directed to ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given, duly attested by the PIO. The PIO is directed to come present in person before the Bench to attend the next hearing. The appellant is also directed to come present in person before the Bench on the next date of hearing failing which the Bench may be constrained to decide the case based on the documents available on file.
6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 26.07.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
