## **ORDER**

- 1. This order may be read with reference to the order dated 31.08.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today. Shri Ankit Sehgal, appellant comes present to attend the hearing in person before the Bench and states that information has been received by him but he is not satisfied with the same.
- 3. Shri Brahmjot Singh, Clerk O/o Municipal Corporation, Amritsar comes present to attend the hearing in person before the Bench on behalf of the PIO. He states that point-wise information has been supplied to the appellant. On the asking of the Bench, he explains the point-wise position, but the appellant expresses dis-satisfaction over the same. Then the Bench directs both the appellant and respondent to sit together in the adjacent court room and the respondent is asked to clarify position on each point and then to report back to the Bench.
- 4. Post meeting, the respondent reports back and states that he has clarified position on each point. However, the appellant is still not satisfied on the information regarding work order issued after calling quotations. The respondent explains to him for the work less than Rs.20,000/-, no work order is issued and after administrative approval, the work is got done. Rest of the approvals are through e-tendering.

Although the Bench is convinced that adequate information stands supplied to the appellant, yet, due to dis-satisfaction expressed by the appellant, the Bench directs the PIO O/o Municipal Corporation, Amritsar to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.692 of 2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and

the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be
