**ORDER:**

1. The RTI application is dated 26.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.10.2022 and the second appeal was filed in the Commission on 22.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 01.03.2023. Accordingly, the case has been heard today. Shri Jasbir Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Gurwinder Singh, AEO/PIO, GMADA, Mohali comes present to attend the hearing through cisco webex. He states that the appellant has been given reply vide letter dated 24.11.2022. He further states that the appellant has been informed that the documents sought by him cannot be provided as the related record is not maintained by the office. PIO is directed to send a copy of the letter on WhatsApp number of appellant as also by e.mail and by registered post today itself.
