ORDER:

5. The PIO-O/o Municipal Corporation(B&R) Branch Jalandhar is impleaded in this case as respondent No.2 and directed to provide point-wise information to the appellant before the next hearing. The PIO is also directed to come present in person before the Bench to attend the next hearing. The PIO O/o Deputy Commissioner, Jalandhar is exempted for further appearance.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on
13.06.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
