ORDER:

- 1. The RTI application is dated 05.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.10.2022 and the second appeal was filed in the Commission on 19.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for 12.07.2023 but it was postponed and the hearing was fixed for today i.e. 31.07.2023.
- 2. In today's hearing, the appellant, Sh. Diwan Chand states that incomplete information has been supplied to him and further requests for remaining information. He further states that the deficiencies had been pointed out by him vide letter dated 25.07.2023.
- 3. The respondent states that the information comprising of 46 pages had already been sent to the appellant vide letter dated 06.03.2023 and no deficiencies had been pointed out by the appellant till date. He adds that an email dated 30.06.2023 had already been sent to the undersigned Bench and taken on record.
- 4. After hearing both the parties and examining the case file, appellant is advised to point out deficiency, specifically in writing to the respondent PIO with a copy to the Commission within 10 days from the receipt of this order, failing which it will be presumed that he has nothing to say in this regard and case will be decided on merits.
- 5. Respondent PIO is directed to remove the discrepancy within 10 days, if any, pointed out by the appellant as per para 4 of this order.
- 6. Both the parties are directed to appear on the next date of hearing to clear the facts of this case.
- 7. This case is adjourned and both the parties are directed to come up **on 01.11.2023 at 11:00 A.M. at Punjab State Information Commission.** Copy of the order be sent to the parties.
