ORDER:

1. This order may be read with reference to the order dated 15.06.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. As per appellant, she has not been provided complete information.
3. As per respondent, a letter was issued to HDFC Bank for providing copies of vouchers but they stated that the letter should be signed by an authorised officer of the department. The authorised officer in this case is DCFA and after getting the letter signed by DCFA, the same has been sent to HDFC bank by the accounts branch. The respondent now wants some more time to collect the information and to provide the same to the appellant.
4. Earlier order stands. The PIO is directed to comply with the earlier order of the Bench and provide point-wise information to the appellant before the next hearing with a copy to the Commission. The PIO is directed to call the appellant to his office on any working day and allow her access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to her before the next hearing.
5. The appellant is advised to contact Shri Harish Grover, Clerk Health Branch O/o MC Ludhiana Mobile No.9779178065 prior to visiting for inspection of records. The PIO is directed to ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO. The PIO is also directed to come present in person before the Bench to attend the next hearing.
6. With the aforesaid directions, **the matter is adjourned. To come up for hearing on 31.07.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
