**ORDER:**

1. This order may be read with reference to the order dated 25.04.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. As per respondent, the information as available in the official records has been provided to the appellant vide letters dated 16.11.2022, 21.02.2023, 17.04.2023 & 02.05.2023.
3. The appellant is not satisfied with the information relating to point-3 & 4 and states that the PIO has not provided the copies of relevant documents submitted by Shri Ramesh Kumar at the time of his promotion and complete file relating to promotions. The respondent however, contends that documents submitted by Shri Ramesh Kumar at the time of his promotion have been provided however, related case file has not been shown as it contains names & details of other persons also about whom information has not been sought.
4. Post deliberations, the PIO is now directed to bring entire record relating to this RTI application in the Commission on the next date of hearing for perusal of the Bench and for inspection of the appellant. The PIO and the appellant are directed to come present in person before the Bench on the next hearing.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 17.07.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
