ORDER:

1. The RTI application is dated 04.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.11.2022 and the second appeal was filed in the Commission on 22.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 01.03.2023. Accordingly, the case has been heard today. Chaudhary Davinder Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex..

3. Shri Raj Kumar Bansal, Administrative Officer/PIO, GMADA, Mohali attends the hearing through cisco webex and states that the RTI application of the appellant has been transferred to PIO, O/o GMADA, Mohali under Section 6(3) of RTI Act, 2005.

4. Shri Gurwinder Singh, AEO/PIO, GMADA, Mohali comes present to attend the hearing through cisco webex. He states that reply has been given to the appellant vide letter dated 07.11.2022 to the effect that no licence has been issued to La Prisma (United Builders) colony by GMADA, as such, no record in this regard is available in the official record.

5. Since the appellant is absent, he is contacted on his mobile phone. He denies the receipt of any information. He is apprised of the reply given by PIO GMADA. The PIO is directed to again send the reply to the appellant on his WhatsApp number as well as by e.mail today itself. He assures to do the needful.

6. In view of the above, the Bench does not feel need for further intervention in the matter. **The instant appal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
