ORDER

1. The RTI application is dated 19.09.2022 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 12.12.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 21.02.2023. The case has been heard today. Shri Jiwan Singh, comes present to attend the hearing in person before the Bench on behalf of complainant Shri Harbans Singh and produces before the Bench authority letter to attend the hearing. He states that the complainant has not received any information.
3. Shri Harmail Singh, XEN, PSPCL Division, Doraha and Shri Avtar Singh, SDO, Sub Division, PSPCL, Ghudani Kalan, Division Doraha, District Ludhiana come present to attend the hearing in person before the Bench and state that the information has been supplied to the complainant vide letter dated 17.02.2023 by registered post with a copy of the same sent to the Commission by e.mail. On the asking of the Bench, Shri Avtar Singh hands over a copy of the same to the representative of complainant in the court itself as the representative of the complainant denies receipt of any information so far.
4. After perusal of the documents provided, the representative of the complainant expresses satisfaction. He, however, states that since the information is required by the complainant in a court case, the PDCO documents which are dated 14.12.2020 may be recorded as received by him today in the court. His observation is affirmed.
5. In view of the above, no further cause of action is left in the matter. **The instant complaint case is disposed off and closed.** Copies of the order be sent to the concerned parties.
