ORDER:

1. The RTI application is dated 29.11.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.12.2022 and the second appeal was filed in the Commission on 27.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. As per respondent, the information had been provided to the appellant vide letter dated 27.10.2022 through registered post. However, the appellant was not satisfied with the response and filed first appeal before the First Appellate Authority who called the appellant for personal hearing on 05.01.2023. After hearing the appellant and the PIO, First Appellate Authority disposed off the appeal upholding the PIO's view. The Commission has also received a copy of information/reply of the PIO through email which is taken on record.
3. The appellant is not satisfied with the information provided.
4. Having gone through the RTI application and copy of reply/information received from the PIO, the Commission finds that the RTI application has been sufficiently replied to with regard to issues raised at point No.1 & 2 of RTI application and point No.3 relates to office of Tehsildar Nakodar.
5. Regarding information relating to point-3, the PIO O/o Tehsildar Nakodar is impleaded in the case and directed to provide information to the appellant on point-3 as sought in the RTI application transferred by the office of DC Jalandhar. The PIO is directed to call the appellant to his office on any working day and allow him access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to him within 21 days. The PIO is directed to

ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO. A copy of RTI application is sent to the PIO-Tehsildar Nakodar along with the order.

6. With the above observations and directions, the case **is disposed off and closed**. Copies of order be sent to all concerned parties.
