**ORDER:**

None is present from the department; an email dated 14.11.2022 is received by the undersigned bench stating therein that during the month of October, 2017 total of 122 permits had been issued and the information in relation to same could not be provided as it relates to 3<sup>rd</sup> party because it contains personal information.

After having detailed discussion and examining the case file, the concerned PIO is directed to supply the point wise reply / information as per RTI application, to the Appellant within 10 days from the date of receipt of this order. He is also directed to appear in person on the next date of hearing to represent this case.

The Appellant is also advised to go through the information, once he had received and point out specific discrepancies, if any, in writing to the Respondent / PIO with a copy to the Commission within 7 days after receipt of information, failing which it would be presumed that he has nothing to say in this regard.
6. With the aforesaid directions, the matter is adjourned for further hearing on **15.02.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties through **registered post**.
