as enumerated in his RTI applications. First Appeals were filed with the First Appellate Authority (FAA) on **27.12.2021** and Second Appeal was filed in the Commission on **23.2.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.11.2022**.

2. Both parties are absent for the fourth successive hearing. It is notable that the appellant Sh. Sarabjeet Singh Gill has not attended single hearing of this Appeal Case nor has he made any communication with the Commission since the filing of this Appeal.
