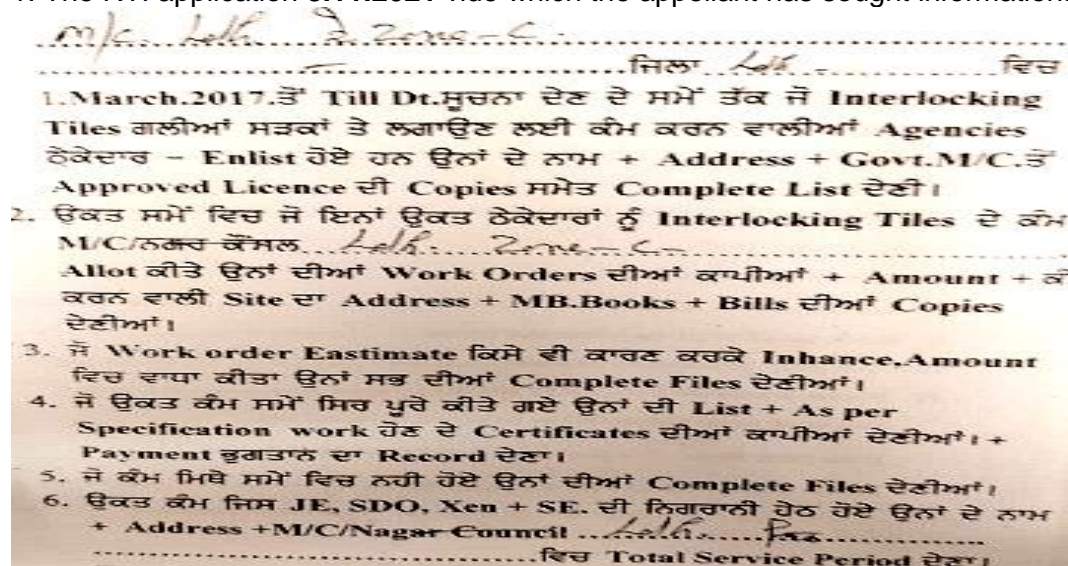

Appeal Case No. 953 of 2022 (Video Conference Proceedings)

2. The appellant is absent. This is despite the Commission's direction, wherein he was asked to attend this hearing in person. Notably, as recorded in this Commission's Order of 22.9.2022, the appellant Sarabjeet Singh Gill, has filed a number of Appeals in the Commission but he has never attended any hearing before this Bench or other benches.

3. Meanwhile, in reply to the Show Cause Notice issued to the PIO vide this Commission's Order on 30.6.222, the respondent PIO, represented by Kulwinder Singh, SDO, has made a submission vide Letter No. 1265 Dated 16.9.2022, wherein he has informed the Commission that a reply was sent to the appellant vide Letter No. 1008 Dated 11.3.2022 wherein the appellant was informed that the information requested by him is "voluminous". The appellant was informed that he could obtain information pertaining to any specific works from the office of respondent PIO on any working day. There has since been no communication from the appellant to the respondent PIO.

4. In view of the above, this Appeal is accordingly **Disposed of**.
