- 2. Both parties are present. The respondent PIO, represented by Satvir Singh, JE, has submitted copy of a reply sent to the appellant vide Letter No. 4419/C Dated 2.11.2022, along with duly attested copies of the information. The Commission has examined said reply alongside the RTI application and finds that the copies of the MBs requested in said RTI application have not been provided. The respondent PIO states that the requested MBs amount to some 9,000 pages and would result in disproportionate diversion of public resources.
- 3. On the appellant's request, the Commission directs the respondent PIO to arrange inspection of the concerned record at 2.00 pm on 9.12.2022. Notably, the appellant has already been sent some 250 pages of information. Any further copies pertaining to the MBs that are sought by the appellant are to be paid at the normal cost of photocopying. Both parties to intimate the Commission following aforesaid inspection.
- 4. This Appeal Case is accordingly **Disposed of**.
