ORDER

1. This order may be read with reference to the order dated 21.09.2022 passed by this Bench on the previous hearing as the hearing scheduled for 31.10.2022 was postponed.
2. The case has been heard today. Shri Prem Kumar Rattan, appellant has not come present to attend the hearing in person before the Bench or through cisco webex. However, a letter dated 28.10.2022 of the appellant is available in the case file pointing out certain deficiencies in the information supplied and has requested for giving the same in the form of an affidavit, if the information is correct.
3. Shri Lakhbir Singh, A.A.E O/o XEN, Sub Division, PSPCL Bhadaur, District Barnala comes present to attend the hearing through cisco webex. He states that the appellant visited their office on 21.10.2022 and requisite information has been supplied to him. 4. The appellant is contacted on phone, but in spite of repeated attempts, he does not respond to the phone calls.
5. The Bench, on hearing the version of the respondent as also on perusal of the contents of affidavit, is convinced that adequate information stands supplied to the appellant.
6. In view of the above, the Bench does not feel need for further intervention in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the parties.
