## **ORDER**

The RTI application is dated 01.11.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 08.02.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

However, the Appellant is not satisfied with information pertaining to point no.'s 3, 4 and 6. The information pertaining to point no's 3, 4 and 6 has been discussed between both the parties today. The respondent however assures the Bench that, as discussed, the information will be provided to
