### **Appeal Case No. 158 of 2023**

#### **ORDER**

1. The RTI application is dated 17.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 02.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 22.02.2023 in the Commission.
3. The Appellant states that he has only received the information at point no. 1 but the same is also not attested. Rest of the information has not been provided to him till date.

### **Appeal Case No. 158 of 2023**

4. The Respondent states that rest of the information cannot be provided to the Appellant as the same falls under Section 8(1) (G) of the Act. They have also filed their reply regarding the same vide Commission diary no. 2814 dated 30.01.2023.

5. After hearing both the parties and perusing the case file, it is ascertained that the Respondent has provided the information pertaining to point no. 1 but the same is not attested. Further, they have filed their reply mentioning that, the rest of the information cannot be provided to the Appellant as the same falls under Section 8(1) (G) of the Act. I have gone through the reply filed by the Respondent and agree with it. However, the Respondent is directed to provide information pertaining to point no. 2 and attested copy of the information pertaining to point no. 1 to the Appellant, within 15 days after receiving these orders, under intimation to the Commission .

With these directions, the Appeal case filed by the Appellant is **disposed off and closed**. Copy of the orders be sent to the parties.
