**ORDER**

1. The RTI application is dated 29.11.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 01.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
