<u>ORDER</u>

5. After perusing the case file, it is ascertained that the Appellant through his RTI application dated 07.04.2022 has demanded the following information:-

The Respondent has filed a copy of their reply, sent to the Appellant regarding his RTI Application as under:-

ਹਵਾਲਾ ਉਪਰੋਕਤ ਵਿਸ਼ੇ ਦੇ ਸਬੰਧ ਵਿੱਚ ਆਪ ਵਲੋਂ ਨਾਲ ਨੱਥੀ ਰਾਸ਼ਨ ਕਾਰਡਾਂ ਦੀ ਡਿਟੇਲ ਸਬੰਧੀ ਅਪਲਾਈ ਕੀਤੇ ਦਸਤਾਵੇਜਾਂ ਦੀ ਕਾਪੀ ਮੰਗੀ ਗਈ ਹੈ।ਉਸ ਸਬੰਧੀ ਆਪ ਨੂੰ ਦੱਸਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਅਪਲਾਈ ਕੀਤੇ ਦਸਤਾਵੇਜਾਂ ਵਿੱਚ ਰਾਸਨ ਕਾਰਡ ਧਾਰਕ ਦੀ ਨਿੱਜੀ ਜਾਣਕਾਰੀ ਹੁੰਦੀ ਹੈ ਜੋ ਕਿ ਕਿਸੇ ਦੂਸਰੇ ਵਿਅਕਤੀ ਨੂੰ ਨਹੀਂ ਦੱਸੀ ਜਾ ਸਕਦੀ।ਇਸ ਲਈ ਆਪ ਵਲੋਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾ ਸਰਕਾਰ ਦੇ ਨਿਯਮਾਂ ਮੁਤਾਬਿਕ ਆਪ ਨੂੰ ਮੁਹੱਈਆ ਨਹੀਂ ਕਰਵਾਈ ਜਾ ਸਕਦੀ।

6. After going through the documents placed on record, it is ascertained that the information sought by the Appellant is relating to the personal information of various ration card holders. Hence, the same is third party information and cannot be provided to him. In view of the above, the Appeal case filed by the appellant is **disposed off and closed**. Copy of the orders be sent to the parties.
