**ORDER**

3. After perusing the documents placed on record, it is ascertained that the Appellant is satisfied with the information provided. However, the orders of the Commission dated 21.12.2021 regarding payment of penalty of Rs 10,000/- have not been complied with. The bench takes a serious note of the same and directs the Respondent-PIO to comply with the orders of the Commission, failing which the bench shall consider an enhancement in the amount of penalty.
