In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer concerned of office of S.D.M., Derabassi, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant under the provisions of the RTI Act, 2005.
- 7. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date in the office of State Information Commission, Punjab, Chandigarh, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. A copy of this order be sent to him through registered post.
- 8. The directions are hereby again been given to the PIO office of S. D. M., Derabassi either to supply the certified copies of the required information to the appellant or file a point wise reply to each and every query, raised by the appellant through his RTI request. He (the respondent PIO) is also directed to remain present during the proceedings of the hearing in the instant appeal-case on the next date of hearing fixed. A copy of this order be sent to him through registered post.
- With this, the case is <u>adjourned to 27<sup>th</sup> February, 2023 at 12:00 P. M. for hearing.</u>
