5. After going through the reply filed by the respondent and examining the RTI of the appellant, it is observed that regarding point no. 2 , the objection of the respondent is upheld. Regarding point no. 3, I overrule the objection of the respondent and direct him to provide the information to the appellant . Regarding point no. 4 respondent filed his reply which is as under:-
