ORDER

1. The RTI application is dated 04.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 05.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 25.01.2023 in the Commission office.
3. The Respondent states that the information demanded by the Appellant cannot be provided as the same is third-party information. Hence, the same is exempt under Section 8(i)(j) of the RTI Act. They have also filed their reply in this regard through e-mail, which is taken on record.
4. The Appellant states that the information demanded by him is in larger public interest. Hence, the same cannot be denied to him. Further, he has also filed his written submission today as under:-

"Sir. I have also brought to your notice that similar type of Fake degrees and fake verification letters of Magadh University, Bodh Gaya Bihar is pending before the Learned Chief Commissioner, Bihar State Information Commission, Chandigarh in Appeal No.3605/2022 & 3606/2022. So you are requested either directed to PIO to supply me desired information or send/club my this appeal with appeal No. 3605/2022 & 3606/2022."
