- 3. Sh. Rajinder Singh, Clerk, who appeared on behalf of the respondent PIO in today's hearing, states that reply has already been sent to the appellant
- 5. Sh. Parminder Singh, who appeared on behalf of the appellant, Ms. Balbir Kaur, in today's hearing with authority letter, states that the respondent has given wrong reply to the appellant.
- 6. After going through the reply sent by the respondent, it is found that the respondent has given wrong reply to the appellant as well as to the Commission without any application of mind. This shows that the respondent has no regard for the RTI regime.
