ORDER

1. The RTI application is dated 10.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 24.01.2023.
2. Notice of hearing was issued to the parties Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).for 21.03.2023 in the Commission. However, the case was postponed to be heard on 24.03.2023,i.e today.

5. After perusing the documents placed on record, it has been ascertained that the subject matter of information demanded by the Appellant in AC-852/2023 and AC-3102/2022, is the same. However, through his RTI dated 10.10.2022 the Appellant has also raised questions/queries which cannot be replied under the RTI Act, as the information which exists in the record can only be provided.
