### **ORDER**

Joginder Pal, Photo And Cinema Officer office of Director, Public Relations, Pb., Chandigarh, who appeared in today's hearing, states that information at point no. 04 of the RTI request has already been supplied to the appellant by Superintendent (Publicity Branch) and a copy of reply is placed in the case-file. He also submits a written-submission dated 12.10.2022, intimating the Commission that the remaining information at point no. 05 and 06 of the RTI request, does not relate with office of Director, Public Relations, Punjab, he also intimates that the remaining information relates with office of Agricultural Department or Revenue Department . Since available information as per official-record has been supplied by the concerned respondent PIOs and the remaining information relates with other department/office, hence, the instant appeal-case is announced as **disposed of and closed** with the advice to the appellant to file a fresh RTI application to the PIO of the concerned department.
