3. The PIO is again absent for today's hearing and he was also absent on the last hearings dated 07.06.2022, inspite of the Notice/Orders of the Commission. This shows his disregard to the Commission. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case.

4. The perusal of the case reveals that the PIO has not provided the complete information to the appellant even after the lapse of the 16 months period.

5. In view of the above, a **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Director, Rural Development & Panchayat Department, Punjab, Sector 62, Vikas Bhawan, S.A.S Nagar (Mohali), to explain as to why penalty should not be imposed upon him for wilful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.

6. The PIO is directed to file reply to the Show Cause Notice and provide the complete information to the appellant and should appear personally through CISCO Webex, on the next date fixed, failing which Rs. 25000/- penalty will be imposed upon him as per provisions of the RTI Act, 2005.

7. The matter is adjourned. To come up for hearing on **11.01.2023 at 11:30 AM in the Commission**. Both the parties are directed to present their case personally.
